	I will update my NC REACH/ ETV profile immediately if my situation (CARS agreement status, childbirth, employment) or ANY of my contact information (email, address, telephone, etc) changes at: <a href="www.ncreach.org">www.ncreach.org</a> or <a href="www.fc2sprograms.org">www.fc2sprograms.org</a>
	To receive continued funding from NC Reach/ ETV, I will request that my registrar's office mail an <u>official</u> transcript of my grades at the end of each term to: 21351 Gentry Drive, Suite 130 Sterling, VA 20166
	Before I withdraw from any class(es) or drop out of school, I will notify my NC Reach/ ETV coordinator by phone in order to remain eligible for future funding.
	I must maintain a GPA of 2.0 or greater. If I fall below a 2.0 GPA in any semester/term, I must participate in the Academic Success Probation Program. If I do not participate in the Academic Success Probation Program, and fail to raise my GPA above a 2.0 the following semester/term, I may no longer be eligible to receive NC Reach/ ETV funding
	I must have my own personal email address. I will check my email at least once a week for emails from NC Reach/ ET and will reply as required.
	I must communicate with my NC Reach/ ETV coordinator by phone at least once a month. If I do not stay in regular communication, my funding may be affected.

	It can take NC Reach/ETV 14 days to process my Financial Aid Release Form from the time the school faxes it.
	At the beginning of each term, I will fill out the top section of the Financial Aid Release Form, and then give it to my school's financial aid office to complete the rest & fax to NC Reach/ ETV. Please keep a completed copy for your records.

The online application is Part 1, the Financial Aid Release form, budget form and signed participation agreement is Part 2 and if I am a returning student, the official transcript from my last NC Reach/ ETV funded semester is Part 3.
